From Adversity to Opportunity Giving Life and Voice to Dreams



Hello, Nobles, Brothers, Ladies and friends all. Thank you for the opportunity to communicate with you again. (In masonry we refer to the exchange of information as a "communication.")

We are truly thankful for all the opportunities afforded us through the fellowship and relationships found in our institutions. We know that many have recovered from great tragedy and adversity. Some have found

opportunities as a result. Our eleemosynary organizations have helped with both.

Consider the lesson from the folkloric story of the obstacle in our path. In ancient times a king had a boulder placed on a roadway, and then he hid himself and watched to see if anyone would remove the huge rock. Some of the king's wealthiest merchants and courtiers came by and simply walked around it. Many loudly blamed the king for not keeping the roads clear, but none did anything about getting the stone out of the way. Then a peasant came along carrying a load of vegetables. Upon approaching the boulder, the peasant laid down his burden and tried to move the stone to the side of the road. With much pushing and shoving he finally succeeded. After picking up his load of vegetables, he noticed a purse lying in the road where the boulder had been. The purse contained many gold coins and a note from the king indicating the gold was for the person who removed the boulder. The peasant learned what many fail to realize. Every obstacle presents an opportunity to improve our condition. Many of you have already begun to realize the symbolism and metaphoric messages contained within this simple story.

Through Shriners charities we help children and their families overcome obstacles. As a result, many find opportunities to help others, to become ambassadors sharing their stories, promoting our hospitals, some even finding career paths.

Recently at Imperial Session in Houston, Texas we met and heard first hand, personal accounts of some of these young people who had found opportunity from triumph over adversity. Initially through depictions on huge semi-panoramic movie screens, then live, we were blessed to witness each tell a unique story of success.

Clint Crain, a teenage boy caught up in a propeller while skiing lost both legs beneath the knee, a hand and suffered injury to other appendages, is now a college student, on a career path as a motivational speaker. He publicly and cogently thanks the Almighty and shiners for miracles and opportunities received.

New slogans were utilized to introduce a new treatment modality for an ubiquitous yet mysterious and devastating disease causing bones to be so brittle they cannot support weight; making children fearful of sneezing or being hugged.

This year the children came up with the slogans. They were asked questions such as "what is love to you;" or "what is happiness?"

On the huge screens, we saw a beautiful little girl with blonde

curls surrounding her perfect face. She said, "Love is holding my daddy's hand." As the camera pans down, we see that she has no hands. The doctors come on screen to describe the lengthy and innovative treatment regime including artificial skin and devices. But then the curtain opens and on stage walks this precious girl -- holding her daddy's hand.

Another young boy said that "happiness is dreaming." Asked "why," he said "In my dreams I can walk." On the screens appear the parents and doctors describing the difficult procedures utilized. But then on stage WALKS this young boy, jumping up and grabbing the microphone from the podium. "In my dreams I walk." Please go to www.shrinersvillage.com to learn more.

In another story, we see on screen a race involving small cars, blazing around the track. Suddenly there before your eyes, there is a collision with a car tumbling over and over. After a crash, there is an explosion, then flames. You see and hear actual footage. Amid gasps and screams. One voice repeatedly yells "Harli get out." This is followed by a fateful response "daddy I can't." Doctors and emergency personnel come on the screen to deliver the dreaded news. She has been burned over eighty-five percent of her body. Then like a ton of bricks, comes the prognosis. The survival rate is usually less than 10% but very unlikely in this case due to the severity and collateral damage from inhalation and internal injuries. Now we hear a young ladies voice saying "when I heard the terror in my daddy's voice I thought it was the end." Hope comes when an uncle arrives and insists that she be flown to a Shiner's hospital. As the story continues we see her again first on screen saying "They not only saved my life but put me back together again" ...then picking up in perfect sequence a live voice takes over "more beautiful than before." The now seventeen year old walks on stage and brothers she is beautiful! She's scheduled to be graduated, plays sports and oh yes...she's back racing cars.

These children have learned to overcome obstacles with the help of Shriners and now find opportunities from adversity. We help give them hope - for a better life and give life and voice to their dreams. Often rewards are found unexpectedly. We never know how, to whom or from whom blessings will come.

Can you find a blessing identifying a child in need, driving patients or giving to these causes.

The pace in Sudan seems to quicken as we head into the fourth quarter. We still have the Grand Lodge, Fall Ceremonial, lots of parades, fish fry's, fundraisers and continuous initiatives and efforts working on our membership.

MEMBERSHIP continues to be our top fraternal issue! Good news from our September 2015 One Day

Ceremonial. We saw 25 new nobles created and join the greatest philanthropy in the world. Their names appear in this publication. We have notified every club and unit of the new nobles and ask that you identify with them if in your area and keep them interested and active. We have to make them feel welcome immediately if we are to keep them interested. I believe what will be done at the Grand Lodge this year will be a first. Sudan, Oasis and Amran have teamed up and will have a booth at the annual NC Grand Lodge on September 25 -26 in Winston Salem. Each temple will have nobles distributing informational packets and talking to non-shrine blue lodge masons in attempts to attract some "Quality Masons" to become "Quality Shriners".

There is a very important article in this issue concerning lifetime Per Capita Membership. Yes, that is correct. Check out the rates in the article and seriously consider this cost savings opportunity. Your per-capita will never increase in the future when the per capita fee goes up at Shriners International.

We have some outstanding news and updates from our Greenville Shriners Hospital. Patient increase saw an overall jump of 18% for the year thus far. Since July 2015, Sudan has had 47 new patients. Our SHC - Greenville Representative, Noble Tim Ludwig reports an increase in patient referrals and the hiring of a sixth physician to keep up with the increased workload.

Sudan swept the Motor Unit Monster Truck Category, and newly formed the Sudan Drifters (May 2015) 1st Place in the Motor Unit - 3 Wheel Category. Let's not forget our Dunn Clowns, Sudan Patrol and the Daredevils taking several 1st places in their individuals association competitions. Every unit should be extremely proud of their performance. Everyone looked sharp and the appearance of equipment and our nobles was second to none. Congratulations to all!

We have recently been faced with some challenges where we might have to make changes in the way we operate. 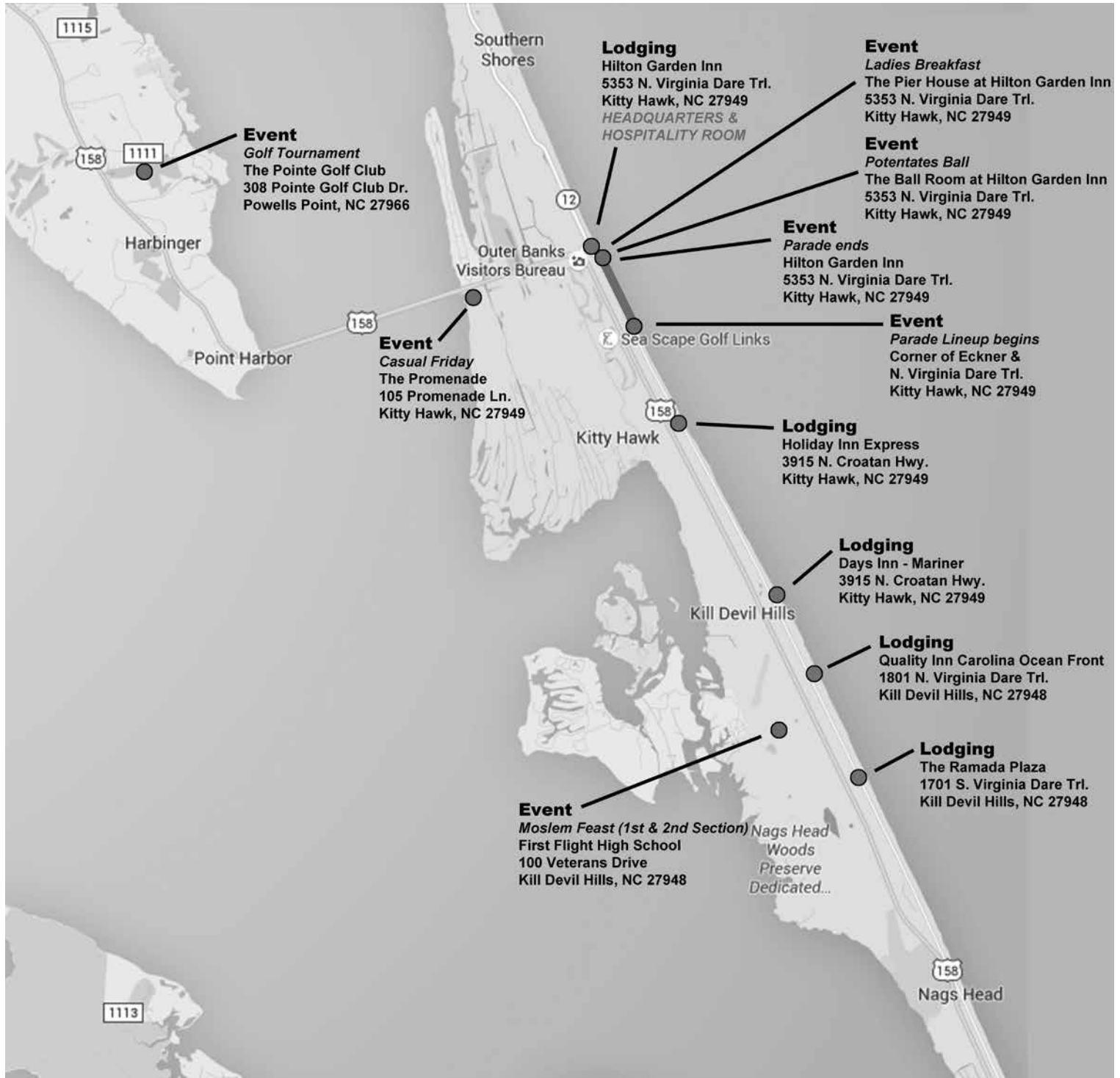

2016 Per Capita Assessment Guidance

During the recent 2015 Imperial Session, action was taken to increase the annual per capita tax in 2016. The following guidance provides direction pertaining to that action including the effective date and application of the life per capita membership provisions of the bylaws.

I. Effective Date of the Per Capita Increase-January 1, 2016

The Per Capita Tax will be \$30.00/member instead of the current \$15.00/member. The Per Capita increase becomes effective for the calendar year 2016 on January 1, 2016. However, dues statements reflecting the per capita increase will be sent to members on or about October 1, 2015. Therefore, the Nobility will begin remitting dues shortly after that date for the 2016 year.

In addition, any Noble who has pre-paid 2016 dues at the \$15.00 rate prior to dues roll-over and receipt of the 2016 dues notification will receive a dues notice for the \$15 difference.

II. Life Per Capita Membership at 2015 Rates

Section 211.5(g) of the Shriners International Bylaws provides, in pertinent part:

“A Noble may pay to his temple recorder a sum equal to 30 times the current per capita tax and, thereafter, he is exempt from the annual per capita tax.”

Therefore, a Noble may avoid the application of the per capita tax increase by becoming a Life Per Capita Member during calendar year 2015. If the Noble submits the sum of \$450.00 to the temple recorder on or before December 31, 2015, he is, thereafter, exempt from payment of the per capita tax. However, if a Noble wishes to become a Life Per Capita Member after December 31, 2015, the sum of \$900.00 will then be payable to the temple recorder based upon the 2016 per capita increase.

Payments received by the Temple Recorder for the Life Per Capita Membership must be posted and recorded as such on the PC report no later than the December 2015 report which is due on January 5, 2016. Payments recorded on the January 2016 or subsequent PC reports will be payable at the increased 2016 rates.

Please note: The Life Per Capita Member should not be confused with a Life Membership which a temple may create exempting the member from the temple's annual dues (§332.6) or with the Hospital Permanent Contributing Membership which exempts the member from the hospital levy (§332.4).

III. Payment of 2016 Dues followed by a 2015 Life Per Capita Membership Payment

With the dues notices being mailed on or about October 1, 2015, it is foreseeable that a Noble may pay the 2016 dues statement in full and, thereafter, submit payment to the temple recorder to become a Life Per Capita Member after paying the 2016 dues but before December 31, 2015. The payment of 2016 dues does not result in a waiver of the ability of the Noble to become a Life Per Capita Member using 2015 per capita rates. In that case, the Noble may be entitled to a credit of \$30.00 for that portion of the dues statement which is attributable to the annual per capita tax included in the notice provided to the Noble for the 2016 dues.

141st IMPERIAL SESSION

SHRINERS

July 5 – 9, 2015

Houston, Texas

Arabia Shriners and Texas Shrine temples hosted the 141st Imperial Session in Houston from July 5 – 9, 2015. An estimated 12,000 Shriners and their families and friends converged on Houston, TX for the annual event.

Most noteworthy of course was election of a former North Carolinian to the position of Imperial Potentate of Shriners International. Imperial Sir Jerry Gantt was born in the Gastonia area and is a former member of Oasis Shriners. Another change in leadership saw the Immediate Past Imperial Potentate Dale Stauss being nominated and elected replacing PIP Douglas Maxwell as the Chairman of Shriners Hospitals for Children, Board of Trustees. PIP Maxwell had served in this capacity since 2009.

Shriners International welcomed the 196th temple to the fraternity. Hikmat Shriners from Brazil was issued their charter on Monday at the opening of the business session.

There were 21 proposed amendments and resolutions submitted for the session. Under Imperial Code, 211.5 Per Capita Tax, there were two items. The first was a motion to increase the Per Capita from \$15.00 to \$30.00. Imperial Sir Bill Bailey made a presentation in favor of the action. There were 16 nobles who presented pros (9) and cons (7) to the recommended change. There were 745 eligible Iowa Corporation voters with 721 in attendance. The report on the ballot was returned with 519 in favor and 219 against. Motion carried. The increase will be added to the dues for 2016. Item # 2 on the agenda was to raise the Per capita \$5.00 a year for the next three years. That item was removed after the passage of item #1.

Other items on the agenda were primarily to do with various temple jurisdictions and waivers, boundaries, request for changes in balloting, with none relative to Sudan Shriners.

A new Imperial Outer Guard was elected. PP Ed Stolze, El Zaribah Shriners, Phoenix, Arizona was elected over PP Richard G. Burke, Yaarab Shriners, Atlanta, Georgia. The ballot was PP Stolze 511 to 212 for PP Burke.

Membership will continue to be the top priority for Shriners International. The number of losses through Shriners International for 2014 was staggering. At the time of this session, Shriners International had 269,555 members. There were 14,070 reported losses for 2014.

Oasis Shriners organized a special dinner event whereby all three temples gathered with their ladies for a dinner with the Most Worshipful Douglas L. Caudle, Grand Master A.F. & A.M. of North Carolina and Lady Angela. Past Imperial Potentate Alan Madsen and Lady Jan, were present to share in the good fellowship.

Three Sudan nobles were reappointed during this session. PP Steve Norris was reappointed as Director for the Membership Committee for the 8th Region. Noble Benny Smith, Sudan Recorder Emeritus was reappointed as the Region 8, Public Relations Representative as well as one of the Imperial Potentate Aides. PP Brack Wilson was reappointed as aide to the Imperial Captain of the Guard, Imp. Sir Kenny Craven from Omar Shriners, SC.

Last week, another Shriner/Roadrunner and I were carrying two one year old boys and their moms to Greenville for the post op check-up after each had previously had one of his legs amputated, due to birth defects. One of the boys I knew, as I had carried him, his mom, and his dad down for their initial hospital appointment, and later, just the boy and his mom for the amputation which occurred about a month ago as I am writing this. I remember thinking last week that it was very odd that we had two one year olds, going to the hospital for the exact same thing who had had their legs amputated at about the same time, at the same Shriner's hospital. It is also seldom that I have ever taken more than one family at a time. Now, I could tell that this whole thing was much harder on the moms than it was on the boys. The babies were singing and cutting up for most of the trip when they were not sleeping. The two moms quietly commiserated about the similarities of their situations, and I know I heard them confiding to each other about some guilt that they each felt. I, as a Shriner and Roadrunner, have a lot of faith and admiration for what goes on at the Shriner Hospitals, so I attempted several times to re-assure these moms that their boys would be okay in the long run. But, I don't think they were buying it, and I think I can understand that. The hospital visits were Friday morning; both babies had the casts from their stumps removed. We loaded up the van and proceeded to return to eastern NC, which takes about 6-7 hours of driving. We stopped for lunch at Wendy's in

Bishopville, SC, just off I-20. I used the rest room after lunch and came out of the restaurant last, knowing that it was my turn to drive, but I saw a middle-aged man at the other end of the van, smiling broadly. I thought he was merely trying to walk between the vehicles to go inside to eat, so I stepped aside to let him pass. But, that was not it. He came toward me and reached out his hand, grasping mine. Many times, other Shriners see us when we are traveling and approach us to give appreciation and sometimes even buy meals for us. But, that also was not it. I could feel from his handshake that he did not have a complete hand; it was more like one long, thin hand with only one digit. As I realized this, he began to talk, still smiling, and almost laughing, as he told us the following. He had seen our van parked and so he stopped because he wanted to talk to the moms. He related to them that he had been a "Shriner" baby over 50 years ago and had his leg amputated. As he said this, I looked down to see his stainless steel prosthesis sticking out of his shorts. He told the moms that things would be okay. He related that he had played sports in high school, even football, and that he was really a pretty good baseball player as a teenager. He also said that he had just recently retired from his job as an EMT after 25 years. I had a joyous feeling run through me as I listened to this man speak to us and as I realized it was exactly what these two mothers needed and wanted to hear. The moms, the other driver and I thanked him for stopping, and we loaded up. The man, still smiling, disappeared as quickly as he had arrived. Too many coincidences to be a coincidence. I believe that God works in very mysterious ways. What else do I repeatedly learn in the course of my travels as a Shriner/Roadrunner? I learn that we should help others as much as we can because it is good for the world and even better for ourselves. I learn to be thankful to God for all of the blessings that it seems like I have taken for granted or didn't recognize for so long. And, I learn to look for and expect miracles like the wonderful counselor sent in Bishopville, SC to calm the fears of the two mothers.

Arab Shrine Club Celebration and Kick-Off Dinner



Debbie Kunselman, sister of Kimberleah (Kim) Rowe Sutton poured her heart out about her sister's journey as a Shriner's hospital patient. Debbie is the wife of Arab Shrine Club member and Sudan Noble Gene Kunselman and was attending the annual Fish-Fry Kick-Off Dinner on September 19th at the club.

Debbie shared that Kim was just five years old in 1962 and was playing in the front yard at her grandmother's house in Rocky Mount, NC when she met a very special Shriner. He had heard about her and stopped to talk to her parents, Audrey and Doug Rowe, and offer hope and real medical help to their youngest of five children. "Your baby girl will never walk", her parents were told by the doctors at birth. What we know as "Love to the rescue" happened because of Shriners. Their story continues as two of Kim and Ted Sutton's three sons were later affected by the same gene disorder. Their muscle disorder remains "unidentified" but genome studies did reveal one gene change.

Kim did walk at about 2 1/2 years old. After becoming a patient at Shriners Hospitals for Children in Greenville, S.C. at five she wore what she describes as "Forrest Gump" braces. When she was fourteen and had experienced the growth spurt the doctors had anticipated prior to her major surgery, wood wedges were placed in her knees and after a month in the hospital, bilateral hamstring muscle transfers were performed on both of her legs. Long-leg casts were worn for three months and then back to braces and the task of gradually gaining knee motion. At age 14, Kim learned to walk again, and in 1972, her braces were permanently removed. Shriners were the link to her improved mobility and selfless service to others through their caring connection and support of Shriners Hospitals for Children.

Kim's oldest son, Edward, a C-17 pilot in the Air Force stationed in Italy, was not affected by the gene. Her son Andrew (29) has had two surgeries at Shriners Hospitals. Her youngest son, Matthew (23) has also had 2 surgeries at our Shriners Hospitals.

According to Captain of the Guard, Noble Lou Smith, this type of Fish Fry Kick-off dinner has been used for years by Fish Fry Chairman Noble Charlie Riggs and the Arab Shrine Club, which is a way to get the membership and their ladies "fired up" for their annual fish fry fundraiser for SHC.

POLICIES & PROCEDURES SHRINE FUNDRAISING

INTRODUCTION

Because Shriners have been the driving force behind Shriners Hospitals for Children, it has become natural to associate the Fez with this charity. However, the Shrine of North America and Shriners Hospitals are separate and distinct legal corporations.

Shriners Hospitals for Children is incorporated in the state of Colorado, and it operates 22 hospitals. Its purpose is to provide medical care to children with disabilities without regard to race, creed, sect or nationality. The treatment for the children is provided at no cost. This is the Charitable corporation.

The Shrine of North America is incorporated in the state of Iowa, and it presently has 195 unincorporated fraternal associations in Canada, Mexico, the United States and Republic of Panama. We know them as Shrine Temples. This is the Fraternal corporation.

A study done by Shriners International Headquarters found that Shrine Temples conduct more than 2,000 fundraising activities annually. Many of these fundraisers are strictly for the Temples – and this is perfectly acceptable. Other fundraising activities are for the benefit of Shriners Hospitals for Children – and this is also perfectly acceptable.

However, the individual purchasing a ticket, product, etc., or the donor, should be advised, in advance, how the proceeds will be used. This pamphlet is intended to provide guidance to the Temples, units, clubs and Nobles in their fundraising activities so there can be no criticism directed at them that the solicitation did not conform to the requirements of the law or was deceptive or misleading.

TYPES OF FUNDRAISERS

There are two types of Shrine fundraisers – Charitable and Fraternal.

CHARITABLE FUNDRAISERS – Where 100 percent of the net proceeds benefit Shriners Hospitals for Children.

FRATERNAL FUNDRAISERS – Where the net proceeds benefit the Temple, which in turn may distribute them as it sees fit. For example, profits may be disbursed to the Temple general fund, a building fund, to clubs and/or units, to Shriners Hospitals for Children, to local community or Masonic related projects (DeMolay, Masonic Home, etc.) or any combination thereof.

PROCEDURES THAT APPLY TO ALL SHRINE FUNDRAISING ACTIVITIES

All fundraising must comply with the law of the land; that is, the law of the jurisdiction where the activity takes place. This includes national, state or province, and local laws.

The use of the name Shriners Hospitals is governed by §503.10 of the bylaws of Shriners Hospitals.

All fundraising is governed by General Orders as may be issued on that subject by the Imperial Potentate.

Insurance. Your attention is particularly called to that portion of the existing General Order #1 pertaining to insurance. Strict compliance is required. All contracts must be reviewed and approved by the Temple Potentate after receiving the advice of the Temple attorney.

All fundraising promotional materials (including Temple publications) must include a statement indicating the major entity benefited by the funds [Statement of Purpose].

STATEMENTS OF PURPOSE

All fundraising promotional materials must contain a STATEMENT OF PURPOSE. Below are examples for each type of fundraising activity.

FOR CHARITABLE FUNDRAISERS:

“Net proceeds from this (activity, event, etc.) are for the benefit of Shriners Hospitals for Children.”

FOR FRATERNAL FUNDRAISERS:

“Net proceeds from this (activity, event, etc.) are for the benefit of XYZ Temple/Unit/Shrine Club.”

DISCLOSURE (for Fraternal fundraisers) “Payments are not deductible as charitable contributions.”

*NOTE: All **fraternal** fundraising materials must include both the statement of purpose and disclosure.*

CHARITABLE FUNDRAISERS

It should be emphasized at this point that a Noble (in his capacity as a Shriner), a Shrine Temple/unit, an organization of Nobles, or affiliated/appendant corporations SHALL NOT engage in any charitable fundraising effort other than for the benefit of Shriners Hospitals for Children.

When a decision is made to conduct a charitable fundraiser, the responsible Noble (club/unit president, committee chairman, etc...) must submit a written request to the Temple Potentate having jurisdiction thereof. If he approves, the Potentate must then obtain the written consent of the Imperial Potentate and Chairman of the Board of Trustees. This request shall be sent to the Executive Vice President – Imperial Council, Shriners International Headquarters, P.O. Box 31356, Tampa, Florida 33631-3356. Final approval for a charitable fundraising activity is effective upon the Temple's receipt of a Charity Activity Form. If a request is denied by the Imperial Potentate and Chairman of the Board of Trustees, the Temple Potentate will receive a full explanation in writing.

One hundred percent of the net proceeds from charitable fundraisers must be given to Shriners Hospitals for Children.

Expenses for operating the event must be actual, and no labor charges can be made for volunteer work by Shriners and/or their families.

Under certain conditions, existing General Orders allow the use of a portion of funds raised for the hospitals to be used for patient transportation.

All solicitation materials, tickets, programs and documents must include factual information (Statement of Purpose) regarding use of the proceeds.

Information about our hospitals (obtainable from the Imperial Public Relations Department), such as patient success stories, facts and figures, photos or other appropriate material, may be used in programs for **charitable** fundraisers.

The Temple shall report the results of each charitable fundraising activity within 60 days of the activity to Shriners

Hospitals for Children on the Charity Activity Form provided to the Temple. A Temple that fails to remit the net proceeds within 60 days of the activity shall be assessed interest retroactive to the date of the activity.

The Temple shall maintain detailed financial records of all fundraising activities involving Nobles, clubs, units, organizations of Nobles or affiliated / appendant corporations for a period of seven years. Details of all revenues and disbursements shall be maintained in such financial records.

State Solicitation Laws: Some states have solicitation laws that may require Shrine compliance. Temples must have their attorney review such laws. By way of example, the State of Florida requires that the following statement be included in all printed solicitation materials, receipts, written confirmation, or reminders of contributions soliciting charitable contributions for Shriners Hospitals. The statement must be conspicuously displayed in all capital letters.

REGISTRATION DOES NOT IMPLY ENDORSEMENT, APPROVAL OR RECOMMENDATION BY THE STATE.

FRATERNAL FUNDRAISERS

A Noble (in his capacity as a Shriner), or a Shrine Temple/club/unit, or an organization of Nobles or affiliated/ appendant corporations must obtain the prior written consent of the Temple Potentate having jurisdiction thereof before engaging in any fundraising activity.

There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.

When the Potentate gives his written consent for a fraternal fundraising activity, a copy of the same shall be mailed to the Executive Vice President – Imperial Council. Further, any printed materials pertaining to the fundraising activity shall be sent to Executive Vice President, Imperial Council if so requested.

All promotional material, tickets, programs and documents must contain a Statement of Purpose and Disclosure.

Information about our hospitals may be used in programs for fraternal fundraisers *provided that each contains the appropriate Statement of Purpose and Disclosure.*

This information must appear in conspicuous location used lettering bold enough to be easily read. Programs and other 'booklet' type materials must include the Statement of Purpose and Disclosure on the front cover or the first page. The Statement of

Purpose and Disclosure should also be included as a part of each fundraising activity advertised in Temple publications.

The Temple shall maintain detailed financial records of all fundraising activities involving Nobles, clubs, units, and organizations, of Nobles or affiliated/appendant corporations for a period of seven years. Details of all revenues and disbursements shall be maintained in such financial records.

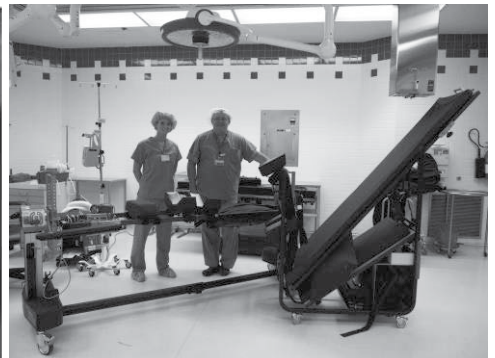
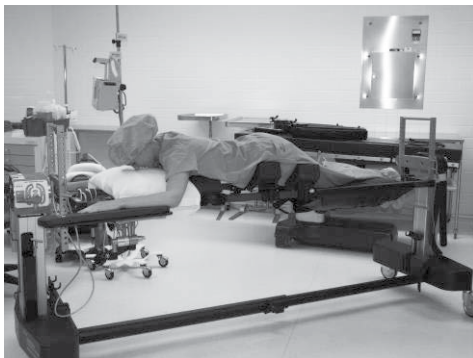
